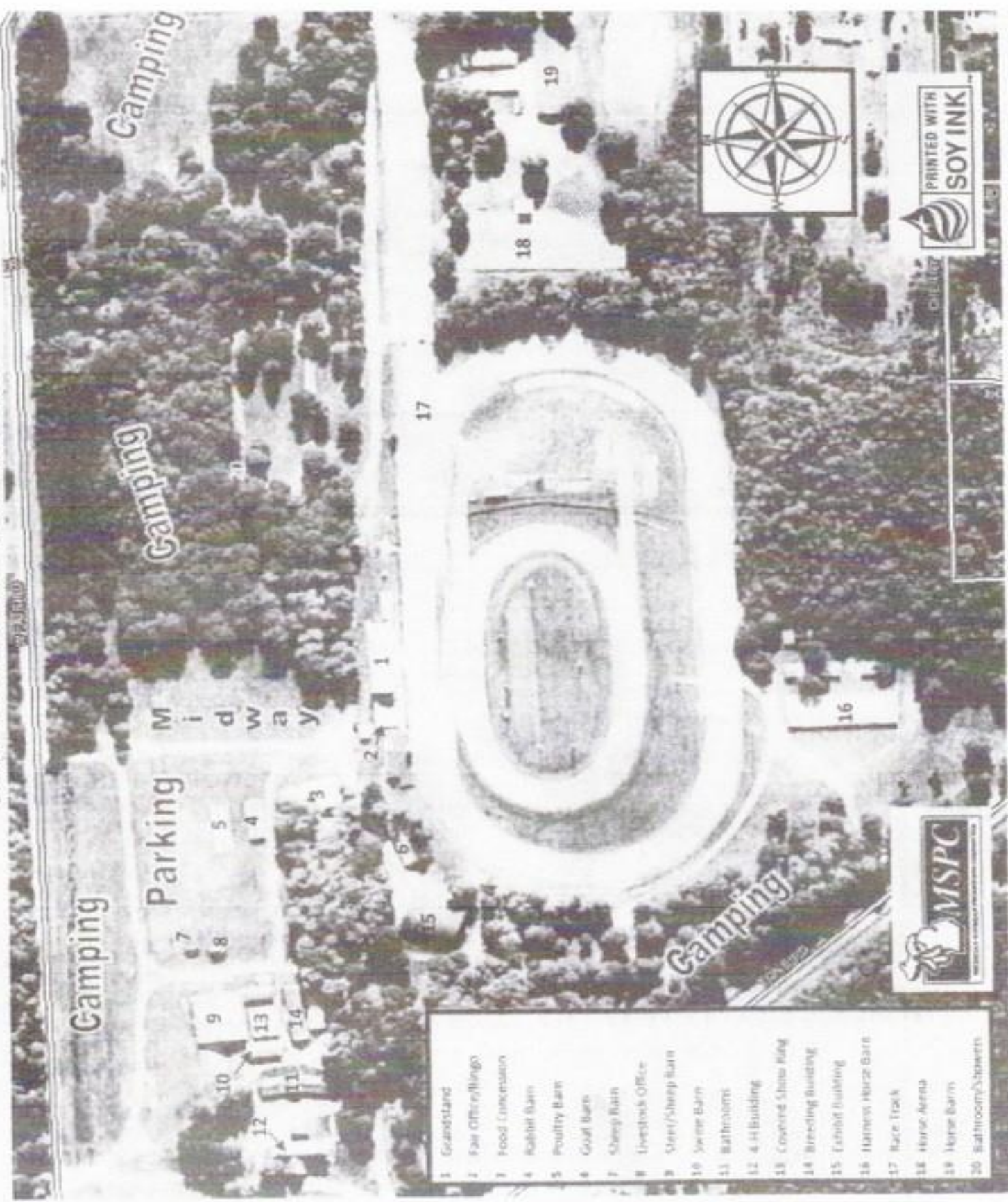

FAIR BOOK COVER WINNER





CONSTITUTION AND BY-LAWS OF THE CHIPPEWA COUNTY FAIR, INC.

SECTION NAME

I. The name of this association shall be "Chippewa County Fair, Inc."

SECTION PURPOSE

II. The purpose of this organization is to encourage the youth in this area to become interested in agriculture and therefore to mature with a healthy interest in the Eastern Upper Peninsula. It is also a purpose of this fair to educate and encourage youth to develop and expand their agricultural skills, citizenship and knowledge.

SECTION MEMBERSHIP

III. Anyone 18 years or older who registers with the Corresponding Secretary 30 days prior to the Annual Meeting each year and pays five (5) dollars membership (this must be paid in person, you may pay for your family members), becomes a member of the association for one (1) year. In order for the member to vote in the election of trustees, run for a trustee position on the board, or vote at committee meetings, the individual must be a registered member of the association at the time of the election. Members must be present to vote, NO proxy votes will be allowed. NO memberships allowed after the cutoff date, which is 30 days prior to the annual meeting

SECTION BOARD OF DIRECTORS

IV. The Board of Directors, shall consist of a President, Vice President, Corresponding Secretary, Recording Secretary, Treasurer and twenty-four trustees, from which the afore-mentioned officers are elected. To have a Quorum, thirteen board members must be present. An elected member of the Fair Board may be replaced if the member misses three consecutive board meetings without a reasonable cause. A quorum of thirteen board members may appoint an individual to fill a vacant trustee seat on the Board of Directors. The individual filling the vacant trustee seat on the Board of Directors shall be selected from the list of nominees from the last annual election. If no names remain on the list or if none of the individuals from the last annual ballot wish to serve, then the person may then be nominated from the floor. Should the President position become vacant during the course of the year, then the Vice President shall assume the presidency for the remainder of the year. Should the Vice President Treasurer, Recording Secretary or Corresponding Secretary position becomes vacant during the course of the year, then the President shall order that a special election be held. The special election will occur within a reasonable time frame after the Vice President, Treasurer, Recording Secretary or Corresponding Secretary position becomes vacant. These individuals shall be elected using a ballot voting system.

SECTION TERM OF OFFICE

V. The term of office for the President, Vice President, Corresponding Secretary, Recording Secretary and Treasurer shall be for one year, beginning and ending at the annual meeting for the prescribed year. Those individuals shall be elected using a ballot voting system. The term of office for the trustees shall be three years, unless an individual has been appointed by the Board of Directors in order to fill a vacant position. In such case, the individual will be appointed for the period of time in order to fulfill the vacant positions term. These individuals shall be elected or appointed using the ballot voting system.

SECTION DUTIES OF OFFICERS

VI. The President shall preside at all meeting of the members, and shall serve as chairperson of the Board of Directors, and shall generally do and perform such services as usually performed by an executive of presiding office. The Vice President shall serve in the absence of the President. The Treasurer shall receive and keep an account of all funds of the Association. All money received by any agent acting on behalf of the Chippewa County Fair, Inc. shall be submitted at once to the Treasurer. The Treasurer will issue the individual a receipt and the receipt shall state the source from which it came and shall be filed at once with the Corresponding Secretary. The Treasurer shall pay out only written orders by the Corresponding Secretary and counter-signed by the President, the order shall state the object of purpose for which the money is drawn. He/she shall report

at the annual meeting, by item all funds received by him/her and the source from which they came, and all funds paid out and object and purpose for which they were paid. NO money shall be borrowed without the consent of the Directors.

Recording Secretary shall be responsible for recording all motions and actions at the monthly, annual and special Fair Board meetings. A report shall be presented at each monthly meeting and a condensed annual report at the annual meeting.

Corresponding Secretary shall be responsible for all correspondence between the Michigan Department of Agriculture and the Chippewa County Fair, Inc., coordination of design and print of the Fair Book, and coordination of class judges.

SECTION ANNUAL MEETING

VII. The Annual meeting shall be held on the 4th Wednesday of January each year at a place designated by the Board of Directors. Members will be notified of the meeting date and location 45 days prior to the meeting. Such notification shall be through social media - fair website and Facebook pages.

SECTION FAIR AND EXHIBITS

VIII. The Board of Directors shall hold yearly a fair at Kinross. All rules, regulations and decisions concerning exhibits, awards, concession, contest, length of the fair and all other items concerning managements shall be controlled by the Board of Directors.

SECTION GENERAL RULES AND REGULATIONS

IX. Board meetings will be held on the 4th Wednesday of the months January through October and the 1st Wednesday of December each year. There will be no meeting the month of November. The organization shall follow all the governing rules set up by the Michigan Department of Agriculture. The board shall follow parliamentary procedures at all meeting of the board. All entry rules shall be found in the individual sections of the fair book.

SECTION AMENDMENTS

X. The Constitution shall only be amended by a 2/3 vote of the members of the Board of Directors present at the annual meeting. Any such changes shall occur only at the annual meeting.

SECTION EX-OFFICIO MEMBERS

XI. The County Extension Director, Fair Manager, Kinross Twp. Supervisor and three 4-H Council Reps., may serve in an advisory capacity to the Board of Directors.

SECTION CORPORATION ORGANIZATION

XII. This corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501C3 of the Internal Revenue Code.

SECTION CORPORATION DISSOLUTION

XIII. Upon dissolution of the corporation, the Board of Trustees shall, after paying or making provisions for payment of all liabilities of the corporation, dispose of all assets of the corporation in such manner, or to such organization organized and operated exclusively for charitable, educational, religious or scientific purposes and shall at the time qualify as an exempt organization or organizations under Section 501C3 of the Internal Revenue Code of 1986, (or corresponding provision of any future United States Internal Revenue law), as the Board of Trustees shall determine. Any such asset not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

AFTER DISSOLUTION OF CORPORATION

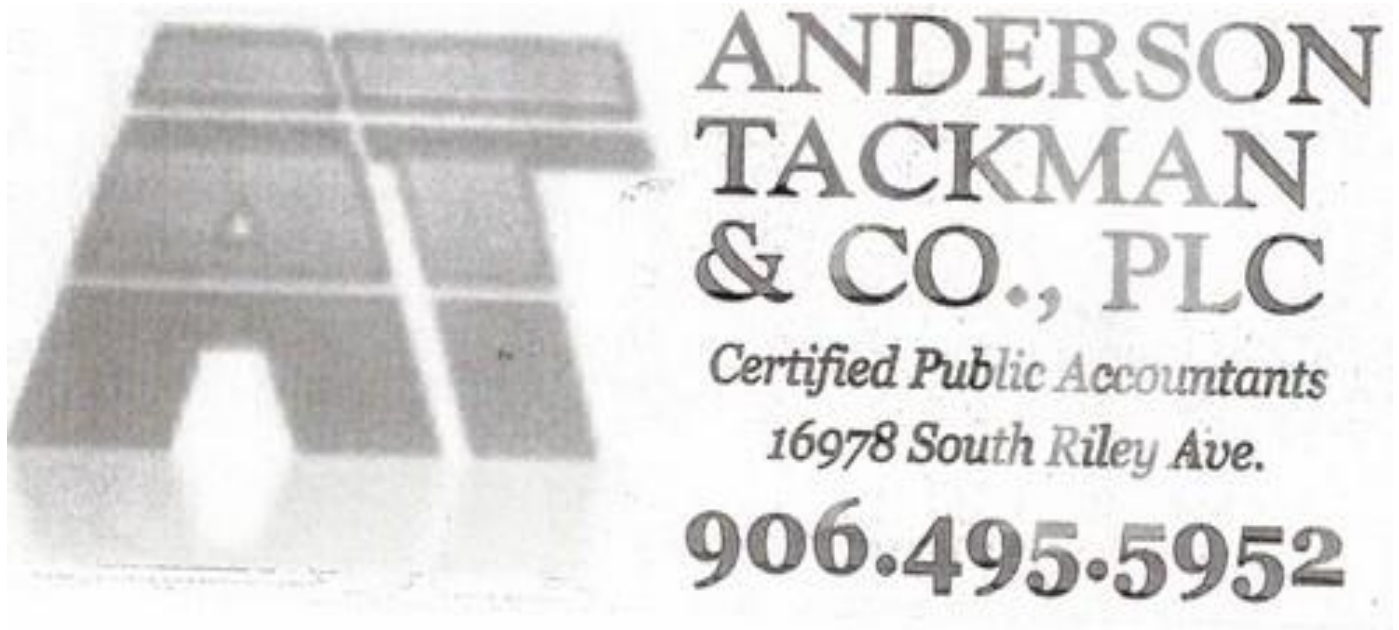
Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501C3 of the Internal Revenue Code of corresponding section of any future federal tax code, or shall be distributed to the federal government or to state or local government, for public purposes. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated for such purposes.

CAMPING RULES AND FORM

1. Pre-registration camping fees are set up for the duration of the fair.
2. Camping fees are the following: \$140 for electric and water, \$120 for electric only, and \$100 for primitive. These rates are for the duration of the fair. **Campers MAY ONLY arrive on the grounds from 12:00 p.m. Saturday, August 23rd to 7:00 p.m. on Sunday, August 24th.**
3. The Camping superintendent shall assign designated campsites by number. Preference will be given to those staying for 9 nights. Other reservations will be granted if space is available.
4. The Camping superintendent shall have full charge of the camping areas, assign locations and collect fees.
5. All campers and tents placed on the fairgrounds will be required to pay a camping fee.
6. Along with camping permit (must be displayed in camper window), you will receive two (2) parking passes per assigned campsite (display in left hand side of windshield). If you wish to purchase additional weekly parking passes, they may be purchased at the office only for \$20 each.
7. Campers arriving without reservation or after the fair has begun, are assigned a campsite on a first come first serve basis.
8. At least ONE adult (a person 21 years of age or older), must be present at the campsite to supervise minors.
9. Reservations for large groups - please send forms and payment together.
10. Pets shall be kept on a leash at all times, and remain under control of the owner. The owner is responsible for cleanup and removal of pet waste. A noisy or abusive pet, will be removed from the grounds upon request. Pets MUST remain on own lot.
11. NO refrigerators are to be OUTSIDE of your camper. NO gray water can be discharged on the ground per state regulations.
12. ABSOLUTLY NO HORSES ALLOWED IN THE CAMPING AREAS.
13. **Camping Registrations must be received no later than June 30 to assure campsite.**
14. Campers wishing to retain the same site as last year, please indicate on form and have request in early.
15. Excessive noise or vulgar language in camp areas is not permitted. Please show respect for other campers.
16. NO stock trailers allowed in camping areas.

Disability Access Accommodation Request for Motorized Cart use

Any motorized cart, if on the fairground, shall require an official Chippewa County Fair permit. Permit applications must be mailed to the fair office - 2568 E. 11 Mile Rd., Dafter, MI 49724

The Chippewa Co. Fair Board will approve or deny all requests at the regular monthly meeting, or if during fair week, at the morning meetings, with each applicant being notified with the final decision. If approval is granted, you may pick-up your permit at the Livestock Office after the first Saturday of the fair.

Permits MUST be attached to the cart while on the fairgrounds.

RULES:

1. **Motorized carts will only be used on designated routes.**
2. **All carts on the fairgrounds shall require an Official Chippewa Co. Fair permit**
3. **Carts are NOT allowed in walkways, in front of the Quonset Hut or in the Midway areas.**
4. **Drivers MUST be at least 16 years of age with a valid driver's license, with their name on the permit.**
5. **The permit MUST be displayed on the cart and be visible.**
6. **The person assigned to the permit MUST be present in the cart at all times when being used and no more passengers than seating allows. There shall be NO people hanging off the cart at any time**
7. **A map will be given with each permit, showing the routes allowed to be used with your cart during the fair week. Carts are only allowed on these routes.**
8. **Any violation of these guidelines may result in towing and impound fees. If found in violation of any of the rules, you WILL NOT be allowed to have a cart on the grounds during future Chippewa Co. Fairs**

2025 HEALTH REQUIREMENTS FOR LIVESTOCK EXHIBITED IN MICHIGAN.

The following is a summary of the health requirements for livestock exhibited in Michigan. The complete set of requirements can be obtained by downloading them from the Michigan Department of Agriculture website" www.michigan.gov/mda-exhibitinfo or by contacting the fair/exposition staff of livestock entry office.

*Livestock means those species of animals used for human food and fiber or those species of animals used for service to humans. Livestock includes but is not limited to cattle, sheep, new world camelids (llamas, alpacas, vicunas and guanacos), goats, bison, privately owned cervids, ratites (cassowaries, kiwis, ostriches and emus), swine, equine, poultry, aquaculture and rabbits. Livestock does not include dogs and cats.

GENERAL

Exhibitors at state, county and district fairs, along with other livestock exhibitions, expositions and shows are required to comply with all statutory and regulatory provisions of the state of Michigan related to animal health outlined in Act No 466 of the Public Acts of 1988, as amended and rules promulgated for the implementation and enforcement of the act.

1. A fair shall have an accredited veterinarian on call whenever there are animals on the premise during the fair. A fair, exhibition, exposition or show authority shall do all of the following in this state.
 - a. Notify exhibitors of health tests and certificates required for importation and exhibitions in this state.
 - b. Examine and approve required health certificates, reports, test charts, certificates or required documentation before displaying, exhibiting or stabling the animals in the exhibition area or before commingling with other animals.
 - c. Notify exhibitors whether or not poultry vaccinated against Infectious Laryngotracheitis (ILT) are allowed in the fair, exhibition, exposition or show.
 - d. Assure that all participating equine test negative for Equine Infectious Anemia (EIA).
2. Livestock with clinical signs of infectious, contagious or toxicological disease shall be removed from the fair, exhibition, exposition or show or by permission of the director, shall be isolated on the premises. Livestock that have known exposure to or that show clinical signs of infectious, contagious or toxicological disease as determined by a veterinarian shall not be displayed or housed at the fair, exhibition, exposition or show unless permission to do so is granted by the director. The fair, exhibition, exposition or show authority is responsible for ensuring that the livestock are removed from the premises.
3. A fair, exhibition, exposition or show authority may require additional testing or vaccinations of animals before entry and during the fair, exhibition, exposition or show.
4. A bird shall not be handled except by the exhibitor, attendant, fair veterinarian, director or judge after the bird is placed in an exhibition coop.
- 5a. Starting March 1, 2007 all cattle moving to a show, sale or exhibition are required to have an official radio frequency identification device (RFID) ear tag. Exhibitors may call North Star Cooperative at 888-203-3398 or National Holstein Association at 1-800-952-5200 to order RFID tags at a cost of \$2.00 per tag.
- 5b. For all Indiana cattle exhibited in Michigan, official RFID ear tags can be ordered by calling Vickie McCune with RJ Matthews Co. at 330-834-3000 ext. 2013 or by calling Amy Bledsoe with the Indiana Animal Health Inc. at 219-279-2378.
6. All goats, sheep and privately-owned cervids shall bear official identification before they leave their home premises.
7. It is the responsibility of the exhibitor to ensure that all requirements for testing, identification and official interstate health certificate of official interstate certificate of veterinary inspection are fulfilled prior to importation and that proof of fulfilling these requirements is provided to the director, fair, exhibition, exposition or show authority upon request.
8. Upon request, a person who exhibits livestock shall present for inspection all reports, test charts, and appropriate health certificates required to accompany the livestock.
9. Out-of-state livestock for exhibition shall meet the requirements prescribed for importation of breeding animals of that species and shall be accompanied by a copy of an official interstate health certificate or an official interstate certificate of veterinary inspection issued by an accredited veterinarian from the state of origin. Livestock shall not be diverted to a premises other than the destination site named on the official interstate health certificate.
10. Whenever an official test is conducted or an official vaccination is administered, livestock shall unless exempted by the director, be permanently identified in a manner approved by the director.
11. Unless otherwise approved by the director, a facility for exhibition of livestock shall be constructed to

allow sufficient separation of each exhibitor's livestock. The facility shall be constructed of a material that can be adequately cleaned and disinfected.

12. An exhibition building or yarding facility shall be cleaned and disinfected with a United States Department of Agriculture approved disinfectant used in accordance with label instructions before livestock are admitted by removing from the premises all manure, litter, hay straw and forage from pens, runways and show rings and thoroughly disinfecting walls, partitions, floors, mangers, awarding facilities and run ways in a manner approved by the director. For a complete list of disinfectants, please refer to www.michigan.gov/mda-exhibitinfo.
13. Feed and water containers provided for exhibition coops shall be new and properly cleaned.
14. A feed or water container from which a bird has eaten or drunk shall be refilled in such a manner as to prevent contamination of the common supply of feed and water. A feed or water container may not be removed from an exhibition coop except for the purpose of cleaning.
15. An exhibition coop shall be thoroughly cleaned and disinfected before and after each exhibition.
16. Primary enclosures and stall areas shall be constructed and place to provide adequate light for proper inspection for evidence of transmissible diseases.
17. Cage litter and bedding shall be clean and shall be replaced daily or as often as needed.
18. A shipping crate used in the shipment of birds by common carrier may not be used as an exhibition coop. Shipping crates shall be cleaned and disinfected on the day of arrival after the birds have been removed for exhibitions and before being used again. Unless otherwise necessary, shipping crates shall not be stored in the exhibition area.

2025 OUT-OF-STATE HEALTH REQUIREMENTS FOR LIVESTOCK EXHIBITED IN MICHIGAN.

The following is a summary of the health requirements for livestock exhibited in Michigan. The complete set of requirements can be obtained by downloading them from the Michigan Department of Agriculture website. www.michigan.gov/mda-exhibitinfo or by contacting the fair/exposition staff of livestock entry office.

Out-of-state livestock for exhibition shall meet the requirements prescribed for importation of breeding animals of that species and shall be accompanied by an official interstate health certificate or an official interstate certificate of veterinary inspection issued by an accredited veterinarian from the state of origin. Livestock shall not be diverted to a premises other than the destination site named on the official interstate health certificate. If vesicular stomatitis outbreaks occurred in the state of origin within the past 30 days, the following statement must be included by the accredited veterinarian on any official interstate health certificate or official certificate of veterinary inspection for importation of equidae, cattle, sheep, goats, bison, New World camelids, swine or privately owned cervidae into Michigan.

"I have examined the animals listed on this certificate and have found no clinical signs of vesicular stomatitis. To the best of my knowledge, these animals have not been exposed to vesicular stomatitis within the previous 30 days nor have they been vaccinated with the vesicular stomatitis vaccine."

All cattle, goats and bison of any age and reproductive capability, unless transported directly to a USDA inspected slaughter facility, must be identified with a USDA approved official identification ear tag, or official breed registration tattoo, prior to importation. An official bred registration tattoo may only be used if the animal is accompanied by the official bred registration certificate during the movement. The official identification must be recorded on the required official interstate health certificate or official certificate of veterinary inspection.

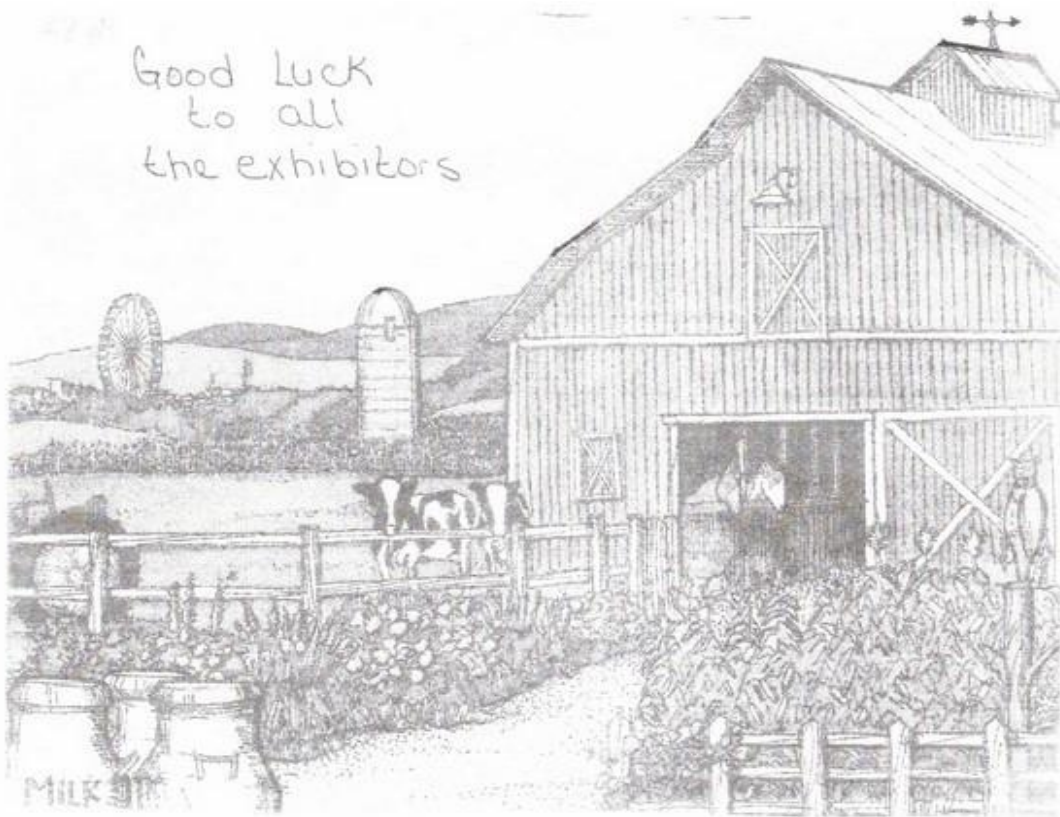
Dairy cattle, breeding cattle, feeder heifers, horse and other equidae, breeding swine, feeder swine, market hogs, llamas, alpacas, privately-owned cervids, aquaculture, and wild animals for exhibition originated outside the state of Michigan shall meet the requirements found at www.michigan.gov/mad-exhibitinfo by contacting the fair/exposition staff of the entry office.

OPEN DEPARTMENT GENERAL RULES

1. Entry fee is \$.50 for each class except where noted.
2. No "For Sale" signs allowed on exhibits. Exhibits may be sold after 9:00 a.m. on Labor Day.
3. All exhibits are entered by the first letter of the exhibitor's last name and the last 4 digits of the exhibitor's Social Security Number, not name.
4. Livestock and Horse exhibitors must be 6 years of age on January 1st of current year to participate in classes which pay premiums. Exception: Breeding Beef exhibitors must be 8 years of age as of January 1st.
5. No one can make more than one entry in each class, except some livestock may have two per class. Poultry may only show one unit per class.
6. Open classes will be placed as shown in their departments. No exhibits may be entered more than one year except livestock. Antiques must not have been shown in the last 3 years.
7. Premiums will be paid to exhibitor by check. All checks must be cashed no later than 90 days.
8. The fair management will not be responsible for any loss, damage or injury to any animal exhibited or for any articles which may be lost or destroyed.
9. All livestock must comply with the Health Requirements for Livestock exhibited in Michigan.
10. ALL LIVESTOCK WILL BE ON EXHIBIT IN THEIR EXISTING PENS UNTIL 9:00 A.M ON LABOR DAY OF THE FAIR. ALL RABBITS AND POULTRY MUST BE REMOVED FROM THE BARN BY 12:00 P.M ON LABOR DAY OR PREMIUMS WILL BE FORFEITED.
11. An exhibitor compelled to bring a complaint regarding conflict of interest of the judge, disqualification of an exhibit or exhibitor, exhibitor group leader or superintendent's behavior, or eligibility of an exhibit shall make a formal protest in writing to the Fair Board no later than 10 days following the end of the fair. There will be a \$50.00 fee for filing the protest with the Fair Board. All protests shall be referred to the Executive Board, which shall review the protest with interested parties and give parties an opportunity to submit evidence. The party against whom the protest was filed shall have the right to read the statement of protest. A report of findings shall be made to the Fair Board for final decision within 10 days of the original complaint. The Fair Board shall issue an opinion within 2 weeks of receiving the recommendation from the Executive Board. An exhibitor may file an appeal to the Department of Agriculture within 45 days of filing the initial complaint if the exhibitor is not satisfied with the Fair Board's action. The Department (MDA) shall have 60 days after receipt of any appropriately filed appeal to investigate the complaint and shall issue a finding of fact and notice of department action and any recommended action for the association. There is a \$25.00 fee to file with the state.
12. The Fair Board reserves the right to prorate premiums listed should available funds fall short of the amount required to allow full payment of premiums.
13. Exhibitors are responsible for correct entry of articles.
14. Sale or distributions of any merchandise including printed and written material, except under a license issued by the fair and/or from a licensed location shall be a misdemeanor.
15. The Fair Board reserves the right to reject exhibitors from the following year's fair due to unruly behavior or failure to cooperate with the superintendent or judges, or for any other reason that the Fair Board determines in its discretion to be appropriate. THE FAIR BOARD DECISION IS FINAL.
16. Livestock classes with less than 3 entries may be combined.
17. Exhibitors of registered animals must furnish up to date papers and transfers upon request.
18. All livestock, including dogs will be charged \$2.00 per class entry fee, except poultry and rabbits will be \$.50 per class. See individual horse section for their class entry fee. ENTRY FEES ARE DUE AT REGISTRATION TIME.
19. All livestock, poultry, rabbit and dog exhibitors must pre-enter with Barb Hillock by August 1st. Every exhibitor must fill out an entry form for each species being shown and sent to Barb. If the registration is not postmarked (No meter mail) by August 1. A LATE FEE OF \$50 PER ANIMAL WILL BE CHARGED. EXHIBITORS WILL HAVE UNTIL THE AUGUST FAIR BOARD MEETING TO PAY THE \$50 IN ORDER TO SHOW. AFTER THE BOARD MEETING NO ENTRIES WILL BE ACCEPTED.
20. All stalls, walkways and pens must be kept cleaned at all times during the fair. All stalls and pens MUST be cleaned immediately upon removal of animals on the Labor Day and approved by the superintendent or premiums will be forfeited.
21. Exhibitor must furnish own hay.
22. FEEDING TIME: Animals must be fed before 9:00 a.m. and between 5:00 and 7:00 p.m. each day. IF you need to water your animal between these times you MUST carry a bucket to the animal in the stall or

pen. Exhibitors must feed animals each day or forfeit premiums. NO ONE OTHER THAN THE ANIMALS OWNER IS ALLOWED TO FEED OR WATER, OR REMOVE THE ANIMAL FROM ITS STALL OR PEN, WITHOUT PERMISSION OF THE OWNER.

23. No animals will be allowed to run free on the fairground
24. All livestock on the fairgrounds must be shown - Exception - any pre-arranged demonstration.
25. STATEMENT OF ANIMAL CARE - The Chippewa County Fair is a showplace for animal agriculture for the county. ALL animals and livestock shown, housed or displayed shall receive care that is humane, healthy, and consistent with accepted practices. Animal care shall be consistent with sound husbandry practices and with rules and regulation set by the Fair Board. Professional veterinary care will be provided as needed at the expense of the owner. Animals experiencing illness or discomfort will be given proper animal care. Exhibitors shall reflect the care and concerns that the State of Michigan and the Chippewa County Fair have for livestock. Humane handling practices of all livestock MUST be used at all times. Not hitting, striking or slapping of animals while in the show ring. You will receive one (1) warning, if you continue you and your animal will be disqualified and removed from the show ring, and will forfeit all premiums received in that species.
26. PROOF OF TB TESTING IS REQUIRED FOR ALL BEEF AND DAIRY. ALL CATTLE MUST HAVE AN OFFICIAL ELECTRONIC ID (RFID) TAG OR THEY WILL BE SENT HOME.
27. POULTRY - Infectious Laryngotracheitis (ILT) vaccinated birds are NOT allowed on the fairgrounds.
28. All sheep and goats being shown MUST have an official USDA scrapie identification tag in their ears, or will be sent home.
29. All horses on the grounds MUST present a current negative Coggins to the Superintendent before unloading.
30. Exhibitors must have possession of all breeding stock 30 days prior to the start of the fair.
31. Professional fitters are not allowed to prepare the exhibitors animals at the fairgrounds.
32. The fair board will be enforcing a quiet time in the barn areas each night. The quiet time is from 11:00 p.m. to 6:00 a.m. each night. This means NO generators, blower, loud radios, etc. in the barn areas between these times.
33. **If an exhibitor cannot handle their beef or dairy animal, and it gets away from them three (3) times, during judging of the animal, you will be disqualified, and must leave the ring, and will be placed last in the class. An adult may not step in and show the animal for the exhibitor.**



YOUTH DEPARTMENT RULES

CROPS, GARDEN, INDUSTRIAL, ART, EDUCATIONAL AND LIVESTOCK EXHIBITS

1. No entry fee will be charged for youth exhibits. Entries will be accepted from 2:00 to 7:30 p.m. on the first Monday of the fair. (Except Livestock) All exhibits must be entered by the first letter of the exhibitor's last name and the last 4 digits of the exhibitor's social security number. One entry per class except some livestock may have two per class. Poultry may show one bird per class except for meat pens. Rabbit exhibitors may show two per class with a total of 10 individual rabbits per exhibitor, 1 meat pen and 1 doe and litter is allowed.
2. All exhibitors must reside in the Tri-County area to exhibit in any youth class. Age levels for youth division premium classes are 3 through 19 on January 1 of current year. Exceptions: dairy ages 6-19 (6 & 7 year olds must show a jr. heifer calf), breeding beef ages 8-19, market beef ages 11-19, sheep ages 6-19, swine ages 8-19, goats, poultry, rabbits, pocket pets and dogs ages 6-19, ponies ages 6-16 and horses 6-19. Pee Wee livestock classes are ages 3-5 on January 1 of the current year with no premiums given.
3. Participants 25 years of age on January 1st of the fair year or younger who have been determined to be eligible for special education services by the local school district, may participate in classes under the educational and demonstration projects.
4. All exhibits must be work done by the exhibitor in the current year. All exhibits must be educational.
5. Exhibits MUST be removed from the youth building between 9:00 a.m. and 10:00a.m. on the Labor Day or premiums will be forfeited. NO "for sale" signs allowed on the exhibits.
6. The Danish system of awarding premiums will be used with A(blue), B(red), and C(white) rating given each exhibit in each class.
7. IF THE OPINION OF THE SUPERINTENDENT AND JUDGE, THE EXHIBIT IS NOT WORTHY, NO PREMIUM WILL BE AWARDED. IF NO PREMIUM IS AWARDED THE JUDGE WILL MAKE A BREIF COMMENT ON THE BACK OF THE EXHIBITOR'S REGISTRATION TAG.
8. The Fair Board reserves the right to pro-rate premiums listed should available funds fall short of the amount required to allow full payment of premiums.
9. Exhibitor is responsible for correct entry of article.
10. All club exhibits must be registered in club and leader's name and address.
11. Ages of exhibitor and project year must be entered on the exhibit tag. All exhibits in the Youth Department Building will be judged against the following score card.
 - A. Education Merit 30%
 1. does the exhibit show what the member has learned?
 2. did the member use good workmanship in presenting the exhibit?
 - B. Attractiveness and Neatness 30%
 1. does the exhibit attract and hold attention?
 - C. Creativeness 30%
 1. is the exhibit creative, original and challenging for the member?
 - D. Appropriate Characteristic 10%
 1. any appropriate consideration for the exhibit being judged, such as taste.

LIVESTOCK RULES - YOUTH DEPARTMENT

1. All exhibitors must reside in the Tri-County area to exhibit in any youth classes. ALL livestock entered MUST have an official tag in its ear upon arrival at the fair. This means beef and dairy animal MUST have a RFID tag. Sheep and goats MUST have a scrapie tag.
2. Each exhibitor must show his/her own animal unless authorized by the superintendent of that department.
3. Pre-entry is required for all livestock, rabbits, poultry and horse by August 1st. Money for open class fee Must be sent with the entry for open division classes. A late fee of \$50 per animal will be charged. Exhibitors will have until the August Fair Board meeting to pay the late fee in order to show. After the August fair board meeting no entries will be accepted.
4. Exhibitors of registered animals must furnish papers and up to date transferred if requested.
5. All youth department dairy animals over 6 months of age must be dehorned.
6. All stalls, pens, and walkways MUST be kept clean at all times. On Labor Day all stalls and pens MUST be cleaned and approved by the species superintendent or premiums will be forfeited.
7. ALL livestock on the fairgrounds MUST be shown, exception - any pre-arranged demonstration livestock.
8. FEEDING TIME: animals MUST be fed before 9:00 a.m. each morning and between 5:00 & 7:00 p.m. each evening during the fair week. If you must water your animal between these times you will need to carry a bucket to the animal in the stall or pen. DO NO REMOVE YOUR ANIMAL FROM IT'S STALL OR PEN. 12. The fair board reserves the right to reject exhibitors from the following years fair due to unruly behavior, or failure to cooperate with the superintendent and judges or for any reason that the fair board determines in its discretion to be appropriate. THE FAIR BOARD DECISION IS FINAL.
13. STATEMENT OF ANIMAL CARE - The Chippewa County Fair is a showplace for animal agriculture for the county. All animals and livestock shown, housed or displayed shall receive care that is humane, healthful, and consistent with accepted practices. Animal care shall be consistent with sound husbandry practices and with the rules and regulations set by the Fair Board. Professional veterinary care will be provided as needed at the expense of the owner/exhibitor. Animals experiencing illness or discomfort will be given proper animal care. Exhibitors MUST notify the superintendent if they feel their animal is ill. Exhibitors shall reflect the care and concerns that the State of Michigan and the Chippewa County Fair have for livestock. Humane handling practices of all livestock MUST be used at all times. NO hitting/striking/slapping will be allowed while in the show ring. You will receive one (1) verbal warning, if you continue you and your animal will be disqualified and removed from the ring. All premiums for that species will be forfeited.
14. The fair management will not be responsible for any loss, damage or injury to any animal exhibited or for any articles which may be lost or destroyed.
15. Youth exhibitors WILL NOT be allowed to wear clothing advertising FARMS or ORGANIZATIONS in the show ring.
16. The exhibitor MUST have possession of all breeding stock 30 days prior to the start of the fair.
17. For sale signs will not be allowed on cages, pens or exhibits. Exhibitors wanting to sell their animal or exhibit may do so after 6:00 a.m. on Labor Day.
18. All livestock MUST remain on exhibit in their existing pen/cage until 6:00 a.m. on Labor Day. All rabbits and Poultry MUST be removed from the barns by 12:00 p.m. on Labor Day, or premiums will be forfeited.
19. The animal being shown in any showmanship class MUST be registered and shown in the exhibitor's name in another class.
20. Professional fitter are not allowed to prepare your animal for the show at the fair.
21. Non-market livestock may arrive at the fair with approval from the species superintendent any time from Sunday To Tuesday at 9:00 p.m.
22. The fair board will be enforcing a quiet time in the barn areas during fair week. The quiet time will be from 11:00 p.m. to 6:00 a.m. each evening. This means NO generators, blowers, loud radios, etc in the barn Areas between these times.
23. The use of drugs or chemical compounds that is not approved by the Food and Drug Administration for use in meat animals is prohibited. Illegal administration of approved drugs and compounds is also prohibited. All animals are subject to blood, urine and tissue tests by the Fair Board, FDA and USDA for illegal substances that exceed the acceptable levels established by the U.S. Department of Agriculture, the FDA, the Food Animal Residue Avoidance Databank and Environmental Protection Agency. A positive

test will result in disqualification. The exhibitor shall assume full responsibility for any violation or regulations related to drugs and medication to include withdrawal times and condemnation of carcasses due to drug rule/regulation violations. This includes forfeiture of all premiums and the Chippewa County Fair sale market value of the animal. All premiums will be withheld until the test has been completed. if the test is positive the exhibitor assumes the cost of the test.

24. Market animals may be shown in showmanship classes but not in breeding classes.
25. All animals must be owned by the exhibitor. Ownership dates are set forth by the individual species and outlined in their respective rules. Ownership means in possession of, cared for, the responsibility of. Ownership will be considered lost if the animal has been cosigned or sold through an auction, even if the exhibitor buys back his/her animal or any other transaction after the final pre-entry identification date set forth by each species. Ownership will be considered lost if the animal is exhibited by another family at any other show. All animals identified, entered and shown at the Chippewa County Fair MUST be housed in the Tri-County area for the duration of the project.
26. **If an exhibitor cannot handle their beef or dairy animal during judging of the animal, and it gets away from them three (3) times, the animal will be disqualified and must leave the ring and will place last in the class. An adult cannot step in and show the animal for the exhibitor.**

MARKET LIVESTOCK RULES

1. All market beef, sheep, swine and goats MUST be brought to the fairgrounds between 10:00 a.m. and 9:00 a.m. on Monday of fair week. The scales will be CLOSED from 5:30 to 6:00 p.m.
2. The owner MUST be present to get his/her animal to the show ring and auction on time. All exhibitors must show his/her own animal unless authorized by the species superintendent and the Fair Board. Exhibitors MUST present to the Fair Board a letter before the August meeting explaining why they will not be able to Show their animal.
2. All market animals MUST have a legible fair and official ear tag upon arrival at the fair. Official tags are RFID (840)
3. for beef, ALL hogs must have either and 840 or pin tag, and ALL sheep and goats MUST have a scrapie tag when they arrive at the fair. If any tags are lost from your market animal ear after being tagged for the fair, you MUST notify the Fair Board at once. If it is a fair tag that is lost we will replace it, if it is the official tag you will need to get a new tag from the breeder. If you arrive at the fair with notifying the Fair Board of a lost tag, you will be charged \$20, that will be removed from your market check.
4. 2 beef, 2 hogs, 4 market lambs, 2 market goats, 2 poultry meat pens, and 2 rabbit meat pens may be identified for your market animal project, however only 1 beef, 1 hog, 2 lambs, 1 goat, 1 poultry meat pen and 1 rabbit meat pen may be shown. An exhibitor may sell 2 large (beef, swine, lamb, or goat) and 1 small (chicken, turkey or rabbit pen) projects or 2 small and 1 large projects through the market livestock sale.
5. All exhibitors must personally own, feed, and prepare their market animals for the ring. Any violation of this rule will disqualify the exhibitor from showing and selling, and the animal MUST be taken off the fairgrounds. Ownership dates are set forth by the individual species and outlined in their respective rules. Ownership means In possession of, cared for, the responsibility of. Ownership will be considered lost if the animal has been Cosigned or sold through an auction, even if the exhibitor buys back his/her animal or any other transaction After the final pre-entry identification date set forth by each species. Ownership will be considered lost if the animal is exhibited by another family at any other show. All animals identified, entered and shown in the Chippewa County Fair MUST be housed in the Tri-County area for the duration of the project.
6. The sale order will be by placement in the show ring. All market animals must be shown to be allowed to sell at the market sale. ALL market Grand & Res. Grand Champion MUST sell. There will no changing of animals after placement of sale is completed. Any market animal the judges declares not finished CAN NOT be sold. ALL SALES ARE FINAL.
7. Ages for showing are the exhibitors age on January 1st of fair year. Market beef 11-19, swine 8-19, sheep 6-19, goats 6-19, poultry 6-19 and rabbits 6-19.
8. 3% of the price received for market animals in the sale will be deducted from each exhibitor's check to cover sale expenses.
9. ENTRY FORMS - every exhibitor must fill out an entry form for each species being shown and sent to Barb Hillock by August 1st. If the registration is not postmarked (no meter mail) by August 1st, a late fee of \$50 per animal will be charged. Exhibitor will have until the August Fair Board meeting to pay this fee in order to show. After the board meeting no entries will be accepted.
10. THANK YOU POSTERS - for all animals sold through the sale MUST be in place by 9:00 p.m. the evening following the sale. If a poster is not in place by 9:00 p.m., \$30 will be withheld from the exhibitor's market sale check.
11. All pens, stalls and walkways MUST be kept clean at all times during the fair. On LABOR DAY all pens, and stalls MUST be cleaned and approved by the species superintendent before leaving, or your premiums will be forfeited.
12. FEEDING TIMES - all animals MUST be fed before 9 a.m. each morning and between 5 and 7 pm each evening during the fair.
13. The fair board reserves the right to reject exhibitors from the following years fair due to unruly behavior or failure to cooperate with the superintendents and judges, or for any reason that the board determines in its discretion to be appropriate. THE BOARD'S DECISION IS FINAL
14. The Chippewa County Fair is a showplace for animal agriculture for the county. All animals and livestock shown, housed, or displayed shall receive care that is humane, healthful, and consistent with accepted practices. Animal care shall be consistent with sound husbandry practices, and with the rules and regulation set by the Fair Board. Professional veterinary care will be provided at the expense of the owner. Animals experiencing illness or discomfort will be given proper care. Exhibitors MUST notify the superintendent if they feel their animal is ill. Humane handling practices of ALL livestock MUST be used at all times. NO hitting/striking/slapping will be allowed while in the show ring. You will receive one (1) verbal warning, if you continue you and your animal will be disqualified and removed from the show ring. If disqualified you will not be allowed to sell your animal through the market livestock sale.

15. The fair management will not be responsible for any loss, damage or injury to any exhibit or for any articles which may be lost or destroyed.
16. The exhibitor and the animal MUST reside in the Tri-County area for the duration of the project. The duration Of the project MEANS from pre-registration date to the day the animal arrives at the fair.
17. Market animals will only be weighed once to determine sale weight. If the animal crosses the scale and does not make weight it must go home. If the animal makes weight it MUST show in a market class it cannot be moved into a breeding class.
18. All market livestock must be fully castrated. ALL market beef MUST not have horns over 2 inches in length. All Market lambs MUST be dehorned and lamb tails must be docked (exception: haired sheep). Market goats will be Allowed to have horns if the exhibitor so wishes.
19. The animal being shown in showmanship class MUST be owned by the exhibitor, exception: if the exhibitor's animal does not make weight, that exhibitor may show an immediate family members animal in showmanship, per fair board approval.
20. Professional fitters are not allowed to prepare your animal for the fair at the fairgrounds.
21. The Fair Board will be enforcing a quiet time in the barn areas each night of the fair. This quiet time will be from 11:00 p.m. to 6:00 a.m., this means NO generators, blowers, loud radios, etc. in the barn areas between these times.
22. **If an exhibitor cannot handle their beef or dairy animal during judging, you will be asked to remove your animal from the show ring and will be placed last in class. An adult cannot step in and show the animal.**
23. If upon arrival at the fair your animal is unruly, you will be required to prove to the species superintendent that you can handle your animal. You will need to bring your animal to the show ring the evening before the show and handle your animal without assistant. If you cannot handle your animal, you may be asked to take your animal home.
24. The use of drugs or chemical compounds that is not approved by the Food and Drug Administration for use in meat animals are prohibited. Illegal administration of approved drugs and compounds are also prohibited. All animals are subject to blood, urine and tissue tests by the Fair Board, FDA and USDA for illegal substances that exceed the acceptable levels established by the U. S. 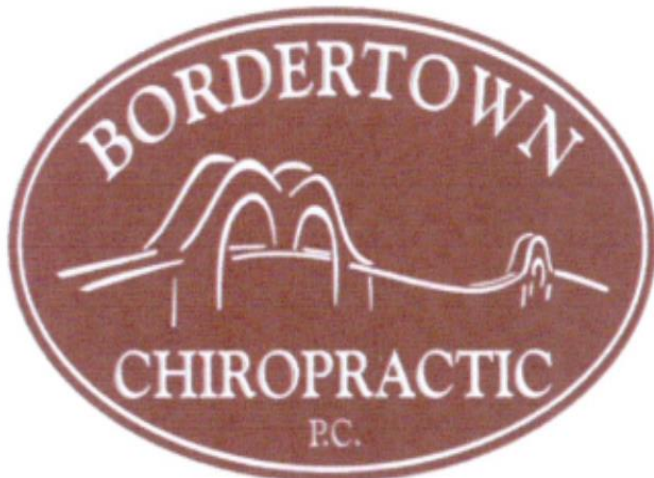

13. Tri-Co bred - must have been born and bred in the tri-county area. The top tri-co bred animal will receive an extra premium of \$100.
14. Record books - if completed must be turned in by 9:00 p.m. on Tuesday of fair week.

First puller is the test puller and will re-pull immediately, if necessary, EXCEPTION - if a class is to be restarted after three (3) tractors have pulled, the first 3 pullers in the class will be consulted as to restarting the class or to continue. If one of the three were disqualified, that puller is excluded from the discussion and possible re-start. Pulling order will be determined by assignment.
2. Tractor may pull twice in class with different driver, placing only once. He/she must remain seated at all times. no bouncing and one hand on steering wheel (verbal warning for 1st offence, 2nd warning will be DQ) and starting with a tight chain. 25ft rule applies-stalling or wrong gear, etc., the puller may start over if he/she stops before 25 ft. Any objects falling off the tractor during hook will result in DQ.
3. Tractor and engine must be brand name with serial #'s in proper place. No alterations that change appearance from the original specs allowed. Engine block, head and carburetors must be standard or acceptable replacement parts for year and model. All tractors must be field worthy, with working brakes. All gasoline engines must be naturally aspirated. No turbos allowed on gasoline engines. Exemption status shall be issued to tractors that are field worthy with replacement engines similar to original (example: FarmAll MD with Detroit diesel replacement engine belonging to Charlie Socolovitch) as it meets all other rules and pulled for exhibition for at least one year with our club.
4. No slipping of clutch or changing gears. Torque AMP shifting permitted provided forward movement of transfer sled tires does not stop. No modified governor controls - no more that 10% RPM over factory specs. Random spot RPM checking will be done at safety committee's discretion.
5. Draw bar height limited to 20 inches - length minimum 18 inches from center of rear tires to point of hook **Must be stationary in all directions** - cannot be connected to any hydraulic assists. Horizontal clevis and or hitching devise with minimum 3-inch opening required for class 2500# through 4500#. Weight classes of 5000# and heavier, pulling hitches MUST be constructed of a minimum of 1/2# thick steel with a 3" diameter hole and at least 3/4" from the inside edge of the hole to the outside edge and attached with a minimum of 2, grade 5, 5/8" bolt, or a minimum of 1 - 3/4" grade 8 bolt.
6. Driver must be at least 12 years of age; a signed permission slip is required (by a legal guardian/parent) for those under the age of 18. Drivers 12-14 must pass a skills test with club rep. on tractor intended to be pulled prior to pulling in 2500# and/or 3000# classes.
7. All weights must be safely secured to the tractor using only original styled weights. Suitcase weights allowed in Farm stock and weight brackets allowed in Antique class and - cannot extend more than 2ft beyond front tire or extend beyond the top rear circumference of the rear tire. All tractors must have workable fenders, approximately the same dimensions as original fenders, including a protected edge.
8. Maximum tire size limited to: Up to 5000# 14.9-38 (200 sq. in or less), 5500# and up 18.4 38(more than 200 sq in), or OEM Tire Size. Shaved, sharpened or cut tires can pull once for exhibition with registration fee paid and time allows. No steel wheeled, lug wheeled or 4-wheel drive tractors allowed. Pressed steel wheels allowed as acceptable replacement.

Tractor must be out of gear while both hitching and unhitching. Any objects falling off tractor during hook will result in DQ.
3. Tractor and engine must be a brand name manufactured through 1960 with serial numbers in proper place. There can be no alterations that change appearance from original specifications. Engine blocks, heads and carburetors must be standard or acceptable replacement part for the year and model tractor. All tractors must be field worthy, with working brakes. All gasoline engines must be naturally aspirated. NO turbos on gasoline engines.
4. No modified governor controls - no more than 10% RPM over factory recommended based on NATPA Chart. Random spot RPM checking will be done at safety committee's discretion. No slipping of clutch or changing of gears. Torque APM shifting permitted provided forward movement of transfer sled tires does not stop.
5. Draw bar height limited to 18 inches to point of hook and must extend beyond rear tires. Must be stationary in all directions - cannot be connected to any hydraulic assists. Horizontal clevis and/or hitching device with a minimum of 3-inch opening required for classes 2,500# through 4,500#, weight classes of 5,000# and heavier, pulling hitches MUST be constructed of a minimum of 1/2", thick steel with a 3" diameter hole and at least 3/4" from the inside edge of the hole to the outside edge and attached with 2 grade 5, 5/8" bolts or a minimum of 1, 3/4" grade 8 bolt.
6. Drivers must be at least 12 years of age - a permission slip, signed by a legal guardian/parent for those under 18 years of age is required. Drivers ages 12-14 must pass a skills test with club rep. on tractors intended to be pulled prior to pulling in 2500# and/or 3000# classes.
7. All weights must be safely secured to tractor using only original styled weights. Suitcase weights allowed in Classic only and weight brackets allowed in Antique classes and cannot extend more than 2ft beyond front tire or extend beyond the top rear circumference of rear tire. All tractors must have workable fenders approximately the same dimensions as original fenders, including a protected edge.
8. Maximum tire size limited to: Up to 5000# 15.5-38, 5500# and up 18.4-38 or OEM Tire Size. Shaved, sharpened or cut tires can pull once for exhibition with registration fee paid and time allows. No steel wheeled, lug wheeled or 4- wheel drive tractors allowed. Pressed steel wheels allowed as acceptable replacement.
9. Shaved, sharpened, cut or radial tires or any tractor that does not conform to the stated rules can pull one time for exhibition and must pay registration fee.
10. Pulling classes- every other pull will start with heavy to light tractors. It will be noted on the pulling schedule. Weight class are listed below.
11. An electronic ground speed and measuring device will provide an accurate measurement and a safe, controlled speed not to exceed 3.5 MPH. If the horn blows 3 times the tractor is disqualified. If the tractor is red flagged and the tractor does not make an immediate effort to stop, that tractor will be disqualified and not allowed to pull for the remainder of the event. The sled operator has the final say on a speed violation in regards to the horn signal.

GARDEN TRACTOR PULL - OPEN CLASSES - SECTION 96

All decisions made by the pulling committee are final.

1. Drivers must be 4-14 years of age, and must have a permission slip signed by a parent or legal guardian, listing name, tractor model, and a disclaimer that the club will not be held liable for any damage to the tractor or harm to the child. Only one signed permission slip per year is required.
2. Drivers must be able to operate the tractor safely, without assistance, wear proper shoes, driver must only operate his/her tractor to and from the pulling area - no joy riding on the grounds
3. Pulling order will be determined by random drawing or by the stats person
4. Tractors must be operated in a safe, slow matter at all times. 3.5 MPH maximum speed, no hot roding. RMP's will be limited to no more than 3,600 RPM'S with a working governor. All tractors will be checked before each pull. One chance to restart if over MPH. All placing tractors will be tached; random spot RPM checking will be done at safety committee's discretion.
5. Tractor will be weighed for one weight class and one tire class only. No class jumping.
6. One tractor may pull twice in same class with 2 different drivers, only one may place. A limit of 2 tractors per driver per class.
7. Weigh in time begins 1 hour before scheduled pull.
8. Track official may help driver hook up to the pulling machine; pit crew must be off the track when the pull begins, the pulling committee, and the workers are the only ones allowed on the track during the pull and there must be NO unsportsmanlike conduct from a parent or guardian.
9. Each driver is allowed 2 consecutive pulls, if time allows, and must keep that tractor within the set boundary lines. Any object falling off during a hook/pull or going outside boundary lines will result in DQ.
10. A driver must remain seated in an upright position at all times while pulling. No leaning or bouncing. Driver must have one hand on the wheel at all times.
11. Any gear is allowable, if speed is not over 3.5 mph, must be no jerking of the chain on the transfer machine, and must be a tight chain to start.
12. If a tractor fails to make it to the machine as scheduled; they will go to the back of the line.
13. All exposed belts must be covered and each tractor must have a working muffler.
14. A drawbar must be clear to hook up to the transfer sled and cannot be more than 10" from the ground. The hitch must be a straight line from the tractor to the point of hitch. The hook must be 1 1/2" hole and easily accessible.
15. Wheelie bars must be used! they must be able to support the weight of the tractor. When the wheelie bars touch down, the bottom of the front tractor tires cannot rise more than 12" off the ground. Wheelie bars must not interfere with the hitch.
16. Weights cannot extend more than 12" behind the rear wheels and height cannot rise more than 32" from the ground up, - for 600# class and 36" for 800# and 1,000# classes. No weights allowed on the seat of the tractor.
17. All tractors must have a throttle-kill switch that is accessible from either side of the tractor and will be tested before each pull
18. No cut tires allowed. Maximum width of tires is 12", maximum height is 32". No tire chains allowed. ATV tires will pull in the bar class
19. No mower decks, 4-wheel drive, two-cycle motors or motorcycle engines. Only garden tractors engines or motors intended for garden tractors are allowed.
20. Running boards and fender must be at least 6" wide and extend out so driver cannot place his/her foot or leg in front of the drive wheel and be pulled off. The fender and running boards must be able to bear the drivers weight.
21. Be sure wheelie bars are strong enough to hold the weight of the tractor. The tractor will be highly scrutinized at weigh-in and must past all inspections before pulling

We acknowledge and accept the fact that all animals entered at the Chippewa Co. Fair may be subject to blood, urine and tissue tests, and that the fair reserves the right to disqualify any animal(s), either live or slaughtered, found in violation of the use of drugs, chemicals or feed additives as described above and in the Chippewa Co. Fair premium book and policy brochure. Disqualification will result in the placing(s) of the animal in question being voided; the forfeiture of any and all ribbons/trophies/special awards earned with the animal(s); the assessment of a fine against the total premiums due equal in the amount of the premium(s) earned with the animal(s); voided of the sale(s) if the animal(s) has been sold in the Chippewa Co. Fair Livestock Sale. We will allow the designated tester/veterinarian to draw any and all samples deemed appropriated from our animal(s).

We will indemnify and hold harmless the Chippewa Co. Fair and all its sponsors and assisting organizations and their employees and agents, against all legal or other proceedings in connection with said testing procedures. We will indemnify and hold harmless Chippewa Co. Fair and its sponsors and assisted organizations against all claims of injury to the animal(s) and any damage or injury to any person or property caused by the animal(s).

Project Animal Care: We, the signed exhibitor and parent/guardian, have read, acknowledge, accept and will abide by all animal care, housing and maintenance rules as set forth in the Chippewa Co. Fair premium book all rules set forth by the department and the appropriate species rules.

We acknowledge that the above-mentioned animal(s) have been under my daily care since the initial tagging or project registration date. Proper care of project animal and maintenance of assigned fair housing is the responsibility of the exhibitor. Project animal(s) must be cared for in accordance with commonly accepted feeding/handling practices, and the animal(s) pen/stall cleaned and bedded as necessary on a daily basis. Proper care and maintenance of all animals and their assigned housing area will be monitored by the appropriate species department superintendent of the fair.

Exhibitor Code of Conduct: We agree to conduct ourselves with honesty, integrity and good sportsmanship. We will treat all fair and livestock show management personal, fair officials, judges and exhibitors with courtesy, cooperation and respect and shall not direct any abusive or threatening conduct toward them. Furthermore, we will not direct criticism or interfere with fair and livestock show management personnel, fair officials, judges and exhibitors in conducting the activities associated with the event. We understand that any conduct that is contrary to these items will be brought before the Fair Board for review and may result in the disqualification of individual people and animal(s) from the activities associated with the Chippewa Co. Ethical and Humane Treatment of Animals: We acknowledge that inhumane fitting, showing and/or handling practices or devices shall not be used. Furthermore, surgery, injection or application of foreign material under and/or into the flesh of any animal to physiologically or physically change the natural contour of conformation of the animal is illegal. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, insertion of foreign material in the animal or other such practices are not acceptable and will be prohibited. Violation of the above-mentioned items could result in the disqualification of the animal and/or exhibitor.

We acknowledge and accept the fact that the Department Superintendent for a given animal species and the Chippewa Co. Fair Board may authorize the examination of a given animal for identification purposes and/or health related concerns in our absence, including obtaining the temperature of the animal in question.

Exhibitor Agreement: I certify that all my animal projects are drug free by FDA standards, I have followed all withdrawal substances used, practiced good animal husbandry, and my project has been ethically and humanely cared for. I acknowledge and accept the fact that my animal(s) may be subject to drug and residue testing. Upon a positive confirmation, forfeiture of all prize monies, sale and/or market value, premiums and trophies will be the forfeiture penalty. My parent/guardian assumes equal responsibility for following these other prescribed guidelines set by the Chippewa Co. Fair Board of Directors and Superintendents for these projects.
